Background on Save the Children

Background information/context

Save the Children in Albania has an ongoing cooperation with Municipality of Tirana aiming to support strengthening of community centre capacities and through them, strengthening the system of social educational services in identification and addressing specific educational needs of children in their territory. The intervention is focused on social inclusion of children affected by multi-dimensional vulnerabilities through support to local actors being institutional or public/non-public service providers to design, plan and deliver socio-educational activities. another component is focused on improving life skills and professionals' abilities for youth in the targeted community centres through collaboration with vocational training and employment offices in Tirana.

The intervention target 4 Community centres established and managed by the Municipality of Tirana in close cooperation and coordination with the Directory of Social Services of the Municipality.



Objective

Save the Children is looking to engage a local expert to support the organization and delivery of youth resilience and life skills sessions across four community centres within the Municipality of Tirana. The selected individual will be responsible for planning and conducting sessions focused on building confidence, enhancing self-esteem, problem solving, conflict resolution and improving social interaction skills among young participants.

Location and official travel involved

The selected individual will conduct the sessions in four community centres in the Municipality of Tirana.

Services the Supplier will provide

- Preparation of the action plan in coordination with each community centre and Save the Children.
- Preparation of PPT and relevant information to be shared with participants based on the theoretical materials developed by Save the Children (resilience and life skills manual)
- Preparation of programs for 12 sessions in each community centre.
- Pre and post-test to measure the knowledge of the participants.
- Preparation of narrative reports in English language for each community centre.

Experience and skill set required

- Bachelor's degree on Social Sciences, psychology/social work or related field.
- Proven experience working in child protection area, previous experience of working with community centres is preferred.
- Demonstrated ability to engage effectively with youth, including through life skills sessions.
- Previous experience of session organization, training delivery on child protection.
- Very good facilitation skills.
- Very Good planning and time management skills.
