Quality /Service (30 %)

- Assessment of the supplier's portfolio to evaluate the quality of your previous photo shooting project. 15%
- Evidence of previous supplier's relevant experience (preferred INGO) and performance history. 15%

Capacity (20 %)

- Delivery Timeline (Ability to meet deadlines for photo delivery after the shoot) 5%
- Equipment and Technology (Availability and quality of cameras, lenses, lighting, and editing software) 10%
- Adherence to RFQ Requirements (Submission of all requested documents, including business registration, tax clearance, and portfolio.) 5%

Sustainability (10 %)

- The Bidder is registered / has its primary operations in close proximity to the programming location. 10%
