- **Language Pairs and Specialization:** Availability of translators for the required language pairs and specialized terminology (e.g., legal, medical, or technical translation). 15%

Capacity (20 %)

- **Turnaround Time and Flexibility:** The ability to meet deadlines and handle urgent or high-volume requests. 10%
- **Adherence to RFQ Requirements:** Submission of all requested documents. 10%

Sustainability (10 %)

- The Bidder is registered / has its primary operations in close proximity to the programming location. 10%
