- **Quick Delivery and Responsiveness Sustainability** Ability to deliver blankets within the shortest possible timeframe, including responsiveness to urgent requests and capacity to meet accelerated delivery schedules. (25 %)

- The bidder is able to demonstrate that he adheres to industrial standards such as ISO 9001.
